

**PhillipMart Announces Pre-IPO Share Price of  
 International Housewares Retail Company Limited (Stock code: 01373)**

(Hong Kong – 24 Sep 2013) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **International Housewares Retail Company Limited** (“**International Housewares Retail**”; stock code: 01373) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **International Housewares Retail** on PhillipMart were HK\$3.06 and HK\$2.92. The price closed at HK\$3.05 per share, 8.54 % higher than its offer price of HK\$2.81. The price opened at HK\$3.00, with the most actively traded price of HK\$3.05 per share, and a turnover of 1,561,000shares. The total trading volume reached 6,949,000shares with total turnover of HK\$20,978,010.00. The final price of **International Housewares Retail**, to debut trading tomorrow has been fixed at HK\$2.81 per share.
