## PhillipMart Announces Pre-IPO Share Price of Hong Kong Finance Group Limited (Stock code: 01273)

(Hong Kong – 30 Sep 2013) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Hong Kong Finance Group Limited** ("**HK Fiance**"; stock code: 01273) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **HK Fiance** on PhillipMart were HK\$1.12 and HK\$0.99. The price closed at HK\$1.01 per share, 1.94% lower than its offer price of HK\$1.03. The price opened at HK\$1.08, with the most actively traded price of HK\$1.00 per share, and a turnover of 1,272,000shares. The total trading volume reached 6,040,000shares with total turnover of HK\$6,235,440.00. The final price of **HK Fiance**, to debut trading at 2 Oct, 2013 has been fixed at HK\$1.03per share.
