

PhillipMart Announces Pre-IPO Share Price of Forgame Holdings Limited (Stock code: 00484)

(Hong Kong – 2 Oct 2013) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Forgame Holdings Limited** ("**Forgame**"; stock code: 00484) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Forgame** on PhillipMart were HK\$60.30 and HK\$55.90. The price closed at HK\$60.10 per share, 17.84% higher than its offer price of HK\$51.00. The price opened at HK\$56.00, with the most actively traded price of HK\$60.00 per share, and a turnover of 104,800shares.
