

PhillipMart Announces Pre-IPO Share Price of Nexteer Automotive Group Limited (Stock code: 01316)

(Hong Kong – 04 Oct 2013) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Nexteer Automotive Group Limited** ("**Nexteer**"; stock code: 01316) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Nexteer Automotive Group Limited** on PhillipMart were HK\$2.84 and HK\$2.80. The price closed at HK\$2.84 per share, 1.43% higher than its offer price of HK\$2.80. The price opened at HK\$2.80, with the most actively traded price of HK\$2.82 per share, and a turnover of 60,000shares. The total trading volume reached 155,000shares with total turnover of HK\$438,100.00. The final price of **Nexteer**, to debut trading has been fixed at HK\$2.80 per share.
