PhillipMart Announces Pre-IPO Share Price of China Ludao Technology Company Limited (Stock code: 02023)

(Hong Kong – 10Oct 2013) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **China Ludao Technology Company Limited** ("**Ludao Technology**"; stock code: 02023) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **China Ludao Technology Company Limited** on PhillipMart were HK\$0.86 and HK\$0.82. The price closed at HK\$0.85 per share, 6.25% higher than its offer price of HK\$0.8. The price opened at HK\$0.84, with the most actively traded price of HK\$0.84 per share, and a turnover of 588,000shares. The total trading volume reached 1,252,000shares with total turnover of HK\$1,054,880.00. The final price of **Ludao Technology**, to debut trading tomorrow has been fixed at HK\$0.8 per share.
