

**PhillipMart Announces Pre-IPO Share Price of
 Ngai Shun Holdings Limited (Stock code: 01246)**

(Hong Kong – 15 Oct 2013) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Ngai Shun Holdings Limited** (“**Ngai Shun Holdings**”; stock code: 01246) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Ngai Shun Holdings** on PhillipMart were HK\$1.14 and HK\$1.02. The price closed at HK\$1.14 per share, 22.58% higher than its offer price of HK\$0.93. The price opened at HK\$1.02, with the most actively traded price of HK\$1.07 per share, and a turnover of 368,000shares. The total trading volume reached 1,288,000shares with total turnover of HK\$1,396,280.00. The final price of **Ngai Shun Holdings**, to debut trading tomorrow has been fixed at HK\$0.93 per share.
