

PhillipMart Announces Pre-IPO Share Price of China Huirong Financial Holdings Limited (Stock code: 01290)

(Hong Kong – 25 Oct 2013) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **China Huirong Financial Holdings Limited** ("**China Huirong**"; stock code: 01290) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **China Huirong** on PhillipMart were HK\$2.35 and HK\$2.19. The price closed at HK\$2.20 per share, 0.92% higher than its offer price of HK\$2.18. The price opened at HK\$2.24, with the most actively traded price of HK\$2.28 per share, and a turnover of 2,158,000shares. The total trading volume reached 10,678,000shares with total turnover of HK\$24,215,840.00. The final price of **China Huirong**, to debut trading has been fixed at HK\$2.18 per share 28Oct.
