## **PhillipMart Announces Pre-IPO Share Price of**

Cabbeen Fashion Limited (Stock code: 02030)

(Hong Kong – 25 Oct 2013) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Cabbeen Fashion Limited ("Cabbeen"; stock code: 02030) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Cabbeen on PhillipMart were HK\$2.68 and HK\$2.59. The price closed at HK\$2.68 per share, 5.93% higher than its offer price of HK\$2.53. The price opened at HK\$2.64, with the most actively traded price of HK\$2.64 per share, and a turnover of 340,000shares. The total trading volume reached 946,000 shares with total turnover of HK\$2,486,100.00. The final price of **Cabbeen**, to debut trading has been fixed at HK\$2.53per share at 28 Oct.
