

## PhillipMart Announces Pre-IPO Share Price of Hydoo International Holding Limited (Stock code: 01396)

(Hong Kong – 30 Oct 2013) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Hydoo International Holding Limited ("Hydoo International"**; stock code: 01396) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Hydoo International** on PhillipMart were HK\$2.20 and HK\$2.06. The price closed at HK\$2.16 per share, 0.47% higher than its offer price of HK\$2.15. The price opened at HK\$2.20, with the most actively traded price of HK\$2.15 per share, and a turnover of 54,000shares. The total trading volume reached 218,000shares with total turnover of HK\$467,460.00. The final price of **Hydoo International**, to debut trading tomorrow has been fixed at HK\$2.15 per share.
