

PhillipMart Announces Pre-IPO Share Price of JingRui Holdings Limited (Stock code: 01862)

(Hong Kong – 30Oct 2013) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **JingRui Holdings Limited** ("**JingRui Holdings**"; stock code: 01862) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **JingRui Holdings** on PhillipMart were HK\$4.60 and HK\$4.30. The price closed at HK\$4.55 per share, 2.25% higher than its offer price of HK\$4.45. The price opened at HK\$4.30, with the most actively traded price of HK\$4.55 per share, and a turnover of 417,000shares. The total trading volume reached 1,110,000 shares with total turnover of HK\$5,040,900.00. The final price of **JingRui Holdings**, to debut trading tomorrow has been fixed at HK\$4.45 per share.
