

**PhillipMart Announces Pre-IPO Share Price of
 China Saite Group Company Limited (Stock code: 00153)**

(Hong Kong – 31 Oct 2013) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **China Saite Group Company Limited** (“China Saite”; stock code: 00153) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **China Saite Group Company Limited** on PhillipMart were HK\$1.03 and HK\$0.98. The price closed at HK\$0.98 per share, 4.85% lower than its offer price of HK\$1.03. The price opened at HK\$1.00, with the most actively traded price of HK\$1.00 per share, and a turnover of 390,000shares. The total trading volume reached 994,000shares with total turnover of HK\$1,002,460.00. The final price of **China Saite**, to debut trading tomorrow has been fixed at HK\$1.03 per share.
