

**PhillipMart Announces Pre-IPO Share Price of
 China Pioneer Pharm Holdings Limited (Stock code: 01345)**

(Hong Kong – 4Nov 2013) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **China Pioneer Pharm Holdings Limited** (“**Pioneer Pharm**”; stock code: 01345) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Pioneer Pharm** on PhillipMart were HK\$3.97 and HK\$3.90. The price closed at HK\$3.90 per share, 4.88% lower than its offer price of HK\$4.10. The price opened at HK\$3.95, with the most actively traded price of HK\$3.95 per share, and a turnover of 187,000shares. The total trading volume reached 353,000shares with total turnover of HK\$1,387,900.00. The final price of **Pioneer Pharm**, to debut trading tomorrow has been fixed at HK\$4.10 per share.
