PhillipMart Announces Pre-IPO Share Price of PW Medtech Group Limited (Stock code: 01358)

(Hong Kong – 7 Nov 2013) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **PW Medtech Group Limited** ("**PW Medtech**"; stock code: 01358) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **PW Medtech** on PhillipMart were HK\$3.22 and HK\$3.01 the price closed at HK\$3.11 per share, 2.2% lower than its offer price of HK\$3.18. The price opened at HK\$3.22, with the most actively traded price of HK\$3.12 per share, and a turnover of 243,000shares. The total trading volume reached 665,000shares with total turnover of HK\$2,075,960.00. The final price of **PW Medtech**, to debut trading tomorrow has been fixed at HK\$3.18 per share.
