## PhillipMart Announces Pre-IPO Share Price of Boyaa Interactive International Limited (Stock code: 00434)

(Hong Kong – 11 Nov 2013) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Boyaa Interactive International Limited** ("**Boyaa**"; stock code: 00434) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Boyaa** on PhillipMart were HK\$7.09 and HK\$6.01. The price closed at HK\$7.09 per share, 32.52% higher than its offer price of HK\$5.35. The price opened at HK\$6.01, with the most actively traded price of HK\$6.90 per share, and a turnover of 1,648,000shares. The total trading volume reached 10,364,000shares with total turnover of HK\$70,697,420.00. The final price of **Boyaa**, to debut trading tomorrow has been fixed at HK\$5.35 per share.
