

PhillipMart Announces Pre-IPO Share Price of China Success Finance Group Holdings Limited (Stock code: 03623)

(Hong Kong – 12 Nov 2013) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **China Success Finance Group Holdings Limited ("China Success Finance"**; stock code: 03623) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **China Success Finance** on PhillipMart were HK\$2.73 and HK\$2.68. The price closed at HK\$2.73 per share, 1.87% higher than its offer price of HK\$2.68. The price opened at HK\$2.68, with the most actively traded price of HK\$2.69 per share, and a turnover of 112,000shares.
