

PhillipMart Announces Pre-IPO Share Price of YuanSheng Tai Dairy Farm Limited (Stock code: 01431)

(Hong Kong – 25 Nov 2013) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **YuanSheng Tai Dairy Farm Limited** ("**YST Dairy**"; stock code: 01431) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **YST Dairy** on PhillipMart were HK\$2.89 and HK\$2.69. The price closed at HK\$2.70 per share, which same with offer price of HK\$2.70. The price opened at HK\$2.89, with the most actively traded price of HK\$2.70 per share, and a turnover of 631,000shares. The total trading volume reached 3,042,000shares with total turnover of HK\$8,404,740.00. The final price of **YST Dairy**, to debut trading tomorrow has been fixed at HK\$2.70 per share.
