

## PhillipMart Announces Pre-IPO Share Price of Yongsheng Advance Materials Company Limited (Stock code: 03608)

(Hong Kong – 26 Nov 2013) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Yongsheng Advance Materials Company Limited** ("**Yongsheng**"; stock code: 03608) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Yongsheng** on PhillipMart were HK\$1.22 and HK\$1.18. The price closed at HK\$1.19 per share, 0.85% higher than its offer price of HK\$1.18. The price opened at HK\$1.21, with the most actively traded price of HK\$1.20 per share, and a turnover of 1,040,000shares. The total trading volume reached 2,215,000shares with total turnover of HK\$2,668,075.00. The final price of **Yongsheng**, to debut trading tomorrow has been fixed at HK\$1.18 per share.
