

# PhillipMart Announces Pre-IPO Share Price of Hengshi Mining Investments Limited (Stock code: 01370)

(Hong Kong – 27 Nov 2013) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Hengshi Mining Investments Limited** ("**Hengshi Mining**"; stock code: 01370) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Hengshi Mining** on PhillipMart were HK\$3.00 and HK\$2.70. The price closed at HK\$3.00 per share, 6.25% lower than its offer price of HK\$3.20. The price opened at HK\$2.70, with the most actively traded price of HK\$2.90 per share, and a turnover of 248,000shares. The total trading volume reached 284,000shares with total turnover of HK\$818,400.00. The final price of **Hengshi Mining**, to debut trading tomorrow has been fixed at HK\$3.2 per share.
