## PhillipMart Announces Pre-IPO Share Price of Phoenix Healthcare Group Co. Limited (Stock code: 01515)

(Hong Kong – 28 Nov 2013) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Phoenix Healthcare Group Co. Limited** ("**Phoenix**"; stock code: 01515) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Phoenix** on PhillipMart were HK\$8.77 and HK\$8.20. The price closed at HK\$8.39 per share, 13.69% higher than its offer price of HK\$7.38. The price opened at HK\$8.20, with the most actively traded price of HK\$8.70 per share, and a turnover of 1,048,500 shares. The total trading volume reached 9.17M shares with total turnover of HK\$78M. The final price of **Phoenix**, to debut trading tomorrow has been fixed at HK\$7.38 per share.
