

**PhillipMart Announces Pre-IPO Share Price of  
 eprint Group Limited (Stock code: 01884)**

(Hong Kong – 2 Dec 2013) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **eprint Group Limited** (“eprint”; stock code: 01884) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **eprint** on PhillipMart were HK\$0.82 and HK\$0.79. The price closed at HK\$0.81 per share, 3.85% higher than its offer price of HK\$0.78. The price opened at HK\$0.8, with the most actively traded price of HK\$0.81 per share, and a turnover of 604,000shares. The total trading volume reached 1,012,000shares with total turnover of HK\$817,520.00. The final price of **eprint**, to debut trading tomorrow has been fixed at HK\$0.78 per share.
