PhillipMart Announces Pre-IPO Share Price of Goldpac Group Limited (Stock code: 03315)

(Hong Kong – 3Dec 2013) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Goldpac Group Limited ("Goldpac Group"; stock code: 03315) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Goldpac Group on PhillipMart were HK\$6.50 and HK\$5.90. The price closed at HK\$6.35 per share, 17.81% higher than its offer price of HK\$5.39. The price opened at HK\$5.90, with the most actively traded price of HK\$6.27 per share, and a turnover of 12,000shares. The total trading volume reached 3,937,000 shares with total turnover of HK\$24,658,340.00. The final price of Goldpac Group, to debut trading tomorrow has been fixed at HK\$5.39 per share.
