

PhillipMart Announces Pre-IPO Share Price of China MeiDong Auto Holdings Limited (Stock code: 01268)

(Hong Kong – 4 Dec 2013) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **China MeiDong Auto Holdings Limited** ("**MeiDong Auto**"; stock code: 01268) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **MeiDong Auto** on PhillipMart were HK\$1.86 and HK\$1.80. The price closed at HK\$1.83 per share, 1.67% higher than its offer price of HK\$1.80. The price opened at HK\$1.83, with the most actively traded price of HK\$1.83 per share, and a turnover of 240,000shares. The total trading volume reached 578,000shares with total turnover of HK\$1,064,340.00. The final price of **MeiDong Auto**, to debut trading tomorrow has been fixed at HK\$1.80 per share.
