

## PhillipMart Announces Pre-IPO Share Price of Huaxi Holdings Company Limited (Stock code: 01689)

(Hong Kong – 5 Dec 2013) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Huaxi Holdings Company Limited** ("**Huaxi Holdings**"; stock code: 01689) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Huaxi Holdings** on PhillipMart were HK\$1.5 and HK\$1.39. The price closed at HK\$1.45 per share, 7.4% higher than its offer price of HK\$1.35. The price opened at HK\$1.39, with the most actively traded price of HK\$1.48 per share, and a turnover of 250,000shares. The total trading volume reached 434,000shares with total turnover of HK\$637,240.00. The final price of **Huaxi Holdings**, to debut trading tomorrow has been fixed at HK\$1.35 per share.
