

PhillipMart Announces Pre-IPO Share Price of Dongpeng Holdings Company Limited (Stock code: 03386)

(Hong Kong – 6 Dec 2013) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Dongpeng Holdings Company Limited** ("**Dongpeng**"; stock code: 03386) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Dongpeng** on PhillipMart were HK\$3.07 and HK\$2.91. The price closed at HK\$3.00 per share, 2.04% higher than its offer price of HK\$2.94. The price opened at HK\$3.00, with the most actively traded price of HK\$3.00 per share, and a turnover of 95,000shares. The total trading volume reached 185,000shares with total turnover of HK\$554,740.00. The final price of **Dongpeng**, to debut trading at 9Dec and it has been fixed at HK\$2.94per share.
