

**PhillipMart Announces Pre-IPO Share Price of  
 Jintian Pharmaceutical Group Limited (Stock code: 02211)**

(Hong Kong – 11 Dec 2013) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Jintian Pharmaceutical Group Limited** (“**Jintian Pharmaceutical**”; stock code: 02211) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Jintian Pharmaceutical** on PhillipMart were HK\$2.98 and HK\$2.80. The price closed at HK\$2.82 per share, 3.09% lower than its offer price of HK\$2.91. The price opened at HK\$2.98, with the most actively traded price of HK\$2.83 per share, and a turnover of 127,000shares. The total trading volume reached 537,000shares with total turnover of HK\$1,528,840.00. The final price of **Jintian Pharmaceutical** 1, to debut trading tomorrow has been fixed at HK\$2.91 per share.
