

PhillipMart Announces Pre-IPO Share Price of Qinhuangdao Port Co., Ltd. (Stock code: 03369)

(Hong Kong – 11 Dec 2013) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Qinhuangdao Port Co., Ltd.** ("**Qinhuangdao**"; stock code: 03369) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Qinhuangdao Port Co., Ltd.** on PhillipMart were HK\$5.10 and HK\$4.80. The price closed at HK\$5.10 per share, 2.86% lower than its offer price of HK\$5.25. The price opened at HK\$4.80, with the most actively traded price of HK\$5.00 per share, and a turnover of 100,000shares. The total trading volume reached 137,000shares with total turnover of HK\$686,000. The final price of **Qinhuangdao**, to debut trading tomorrow has been fixed at HK\$5.25 per share.
