

## PhillipMart Announces Pre-IPO Share Price of PRC B1512- (Stock code: 86615)

(Hong Kong – 11 Dec 2013) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **PRC B1512** ("**Bonds**"; stock code: 86615) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Bonds** on PhillipMart were CNY100.30 and CNY99.85. The price closed at CNY100 and same with the offer price. The price opened at CNY99.85, with the most actively traded price of CNY100 per share, and a turnover of 3,600shares.
