

PhillipMart Announces Pre-IPO Share Price of China Conch Venture Holdings Limited (Stock code: 00586)

(Hong Kong – 18 Dec 2013) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **China Conch Venture Holdings Limited** ("**Conch Venture**"; stock code: 00586) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Conch Venture** on PhillipMart were HK\$14.50 and HK\$13.50. The price closed at HK\$14.44 per share, 6.49% higher than its offer price of HK\$13.56. The price opened at HK\$13.60, with the most actively traded price of HK\$14.00 per share, and a turnover of 2,778,500 shares. The total trading volume reached 7,510,000 shares with total turnover of HK\$105,000,000. The final price of **Conch Venture**, to debut trading tomorrow has been fixed at HK\$13.56 per share.
