

**PhillipMart Announces Pre-IPO Share Price of
 Kerry Logistics Network Limited (Stock code: 00636)**

(Hong Kong – 18 Dec 2013) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Kerry Logistics Network Limited** (“**Kerry Logistics**”; stock code: 00636) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Kerry Logistics** on PhillipMart were HK\$11.78 and HK\$10.50. The price closed at HK\$11.78 per share, 15.49% higher than its offer price of HK\$10.20. The price opened at HK\$10.50 with the most actively traded price of HK\$11.30 per share, and a turnover of 992,000shares. The total trading volume reached 4,592,000shares with total turnover of HK\$52,084,210.00. The final price of **Kerry Logistics**, to debut trading tomorrow has been fixed at HK\$10.20 per share.
