

PhillipMart Announces Pre-IPO Share Price of econtext Asia Limited (Stock code: 01390)

(Hong Kong – 18 Dec 2013) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **econtext Asia Limited** ("**econtext**"; stock code: 01390) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **econtext** on PhillipMart were HK\$4.28 and HK\$3.80. The price closed at HK\$4.26 per share, 18.66% higher than its offer price of HK\$3.59. The price opened at HK\$3.80, with the most actively traded price of HK\$4.05 per share, and a turnover of 940,000shares. The total trading volume reached 7,545,000shares with total turnover of HK\$30,652,820.00. The final price of **econtext**, to debut trading tomorrow has been fixed at HK\$3.59 per share.
