

## PhillipMart Announces Pre-IPO Share Price of Fu Shou Yuan International Group Limited (Stock code: 01448)

(Hong Kong – 18 Dec 2013) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Fu Shou Yuan International Group Limited ("Fu Shou Yuan";** stock code: 01448) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Fu Shou Yuan** on PhillipMart were HK\$5.20 and HK\$4.00. The price closed at HK\$5.20 per share, 56.16% higher than its offer price of HK\$3.33. The price opened at HK\$4.00, with the most actively traded price of HK\$5.00 per share, and a turnover of 2,350,000shares. The total trading volume reached 28,390,000shares with total turnover of HK\$136,575,390.00. The final price of **Fu Shou Yuan**, to debut trading tomorrow has been fixed at HK\$3.33per share.
