

## PhillipMart Announces Pre-IPO Share Price of Consun Pharmaceutical Group Limited (Stock code: 01681)

(Hong Kong – 18 Dec 2013) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Consun Pharmaceutical Group Limited** (“**Consun Pharmaceutical**”; stock code: 01681) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Consun Pharmaceutical** on PhillipMart were HK\$5.00 and HK\$4.60. The price closed at HK\$4.95 per share, 13.53% higher than its offer price of HK\$4.36. The price opened at HK\$4.60, with the most actively traded price of HK\$4.95 per share, and a turnover of 1,947,000shares. The total trading volume reached 8,000,000shares with total turnover of HK\$39,481,490.00. The final price of **Consun Pharmaceutical**, to debut trading tomorrow has been fixed at HK\$4.36 per share.
