

**PhillipMart Announces Pre-IPO Share Price of
 China Creative Home Group Limited (Stock code: 01678)**

(Hong Kong – 19Dec 2013) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **China Creative Home Group Limited (Stock code: 01678)** (“**Creative Home Group**”; stock code: 01678) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Creative Home Group** on PhillipMart were HK\$1.89 and HK\$1.79. The price closed at HK\$1.89 per share, 5% higher than its offer price of HK\$1.80. The price opened at HK\$1.80, with the most actively traded price of HK\$1.80 per share, and a turnover of 390,000shares. The total trading volume reached 1,462,000shares with total turnover of HK\$2,661,540.00. The final price of **Creative Home Group**, to debut trading tomorrow has been fixed at HK\$1.80 per share.
