PhillipMart Announces Pre-IPO Share Price of

Pre-IPO highest and lowest trading prices for **Fuguiniao** on PhillipMart were HK\$9.00 and HK\$8.90. The price closed at HK\$8.90 per share, 1.02% higher than its offer price of HK\$8.81.
