## PhillipMart Announces Pre-IPO Share Price of Logan Property Holdings Company Limited (Stock code: 03380)

(Hong Kong – 19Dec 2013) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Logan Property Holdings Company Limited (Stock code: 03380)** ("**Logan Property**"; stock code: 03380) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Logan Property Holdings** on PhillipMart were HK\$2.15 and HK\$2.10. The price closed at HK\$2.15 per share, 2.381% higher than its offer price of HK\$2.10. The price opened at HK\$2.10, with the most actively traded price of HK\$2.15 per share, and a turnover of 770,000 shares. The total trading volume reached 1,280,000 shares with total turnover of HK\$2,750,000. The final price of **Logan Property**, to debut trading tomorrow has been fixed at HK\$2.10 per share.
