

PhillipMart Announces Pre-IPO Share Price of Nanjing Sinolife United Company Limited (Stock code: 03332)

(Hong Kong – 14Jan 2014) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Nanjing Sinolife United Company Limited** ("Sinolife United"; stock code: 03332) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Sinolife United** on PhillipMart were HK\$2.90 and HK\$2.40. The price closed at HK\$2.65 per share, 32.50% higher than its offer price of HK\$2.00.
