

**PhillipMart Announces Pre-IPO Share Price of  
 Magnum Entertainment Group Holdings Limited (Stock code: 02080)**

(Hong Kong – 22 Jan 2014) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Magnum Entertainment Group Holdings Limited** (“Magnum”; stock code: 02080) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Magnum** on PhillipMart were HK\$3.12 and HK\$2.51. The price closed at HK\$2.80 per share, 86.67% higher than its offer price of HK\$1.50. The price opened at HK\$2.80, with the most actively traded price of HK\$2.80 per share, and a turnover of 2,676,000shares. The total trading volume reached 13,736,000 shares with total turnover of HK\$38,803,000.00. The final price of **Magnum**, to debut trading tomorrow has been fixed at HK\$1.50 per share.
