

PhillipMart Announces Pre-IPO Share Price of BAIOO Family Interactive Limited (Stock code: 02100)

(Hong Kong – 09 April 2014) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **BAIOO Family Interactive Limited ("BAIOO**"; stock code: 02100) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **BAIOO** on PhillipMart were HK\$2.10 and HK\$1.96. The price closed at HK\$2.10 per share, 2.33% lower than its offer price of HK\$2.15. The price opened at HK\$1.96, with the most actively traded price of HK\$1.97 per share, and a turnover of 352,000shares. The total trading volume reached 540,000shares with total turnover of HK\$1,062,200.00. The final price of **BAIOO**, to debut trading tomorrow has been fixed at HK\$2.15 per share.
