

PhillipMart Announces Pre-IPO Share Price of Wang Tai Holdings Limited (Stock code: 01400)

(Hong Kong – 24 April 2014) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Wang Tai Holdings Limited ("Wang Tai"**; stock code: 01400) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Wang Tai** on PhillipMart were HK\$0.76 and HK\$0.72. The price closed at HK\$0.76 per share, 5.56% higher than its offer price of HK0.72. The price opened at HK\$0.73, with the most actively traded price of HK\$0.73 per share, and a turnover of 800,000shares. The total trading volume reached 1,565,000shares with total turnover of HK\$1,153,200.00. The final price of **Wang Tai**, to debut trading tomorrow has been fixed at HK\$0.72per share.
