

**PhillipMart Announces Pre-IPO Share Price of Sunfonda Group Holdings Limited (Stock code: 01771)**

(Hong Kong – 14 May 2014) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Sunfonda Group Holdings Limited** (“**Sunfonda Group**”; stock code: 01771) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Sunfonda Group** on PhillipMart were HK\$3.79 and HK\$3.60. The price closed at HK\$3.79 per share, 4.99% higher than its offer price of HK\$3.61. The price opened at HK\$3.60, with the most actively traded price of HK\$3.70 per share, and a turnover of 156,000shares. The total trading volume reached 351,000shares with total turnover of HK\$1,296,230.00. The final price of **Sunfonda Group**, to debut trading tomorrow has been fixed at HK\$3.61 per share.
