## **PhillipMart Announces Pre-IPO Share Price of Baguio Green Group Limited (Stock code: 01397)**

(Hong Kong – 21 May 2014) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Baguio Green Group Limited ("Baguio Green"; stock code: 01397) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Baguio Green** on PhillipMart were HK\$1.34 and HK\$1.12. The price closed at HK\$1.26 per share, 5% higher than its offer price of HK\$1.20. The price opened at HK\$1.34, with the most actively traded price of HK\$1.20 per share, and a turnover of 1,832,000 shares. The total trading volume reached 11,912,000 with total turnover of HK\$14,418,600. The final price of **Baguio Green**, to debut trading tomorrow has been fixed at HK\$1.20 per share.
