PhillipMart Announces Pre-IPO Share Price of

China CNR Corporation Limited (Stock code: 06199)

(Hong Kong - 21May 2014) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of China CNR Corporation Limited ("China CNR"; stock code: 06199) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for China CNR on PhillipMart were HK\$5.18 and HK\$5.06. The price closed at HK\$5.17 per share, its same as offer price. The price opened at HK\$5.18, with the most actively traded price of HK\$5.10 per share, and a turnover of 240,500shares. The total trading volume reached 616,000shares with total turnover of HK\$3,154,825.00. The final price of China CNR, to debut trading tomorrow has been fixed at HK\$5.17 per share.
