

PhillipMart Announces Pre-IPO Share Price of Best Pacific International Holdings Limited (Stock code: 02111)

(Hong Kong – 22May 2014) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Best Pacific International Holdings Limited ("Best Pacific**"; stock code: 02111) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Best Pacific** on PhillipMart were HK\$2.18 and HK\$2.15. The price closed at HK\$2.18 per share, 1.4% higher than its offer price of HK\$2.15. The price opened at HK\$2.15, with the most actively traded price of HK\$2.15 per share, and a turnover of 58,000shares. The total trading volume reached 124,000shares with total turnover of HK\$267,320.00. The final price of **Best Pacific**, to debut trading tomorrow has been fixed at HK\$2.15 per share.
