PhillipMart Announces Pre-IPO Share Price of Dynagreen Environmental Protection Group (Stock code: 01330)

(Hong Kong – 18 June 2014) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Dynagreen Environmental Protection Group ("Dynagreen Environmental**"; stock code: 01330) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Dynagreen Environmental** on PhillipMart were HK\$3.75 and HK\$3.50. The price closed at HK\$3.63 per share, 5.22% higher than its offer price of HK\$3.45. The price opened at HK\$3.55, with the most actively traded price of HK\$3.70 per share, and a turnover of 3,682,000shares. The total trading volume reached 12,594,000shares with total turnover of HK\$46,274,680.00. The final price of **Dynagreen Environmental**, to debut trading tomorrow has been fixed at HK\$3.45 per share.
