

**PhillipMart Announces Pre-IPO Share Price of  
 Tianhe Chemicals Group Limited (Stock code: 01619)**

(Hong Kong – 19 June 2014) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Tianhe Chemicals Group Limited** (“**Tianhe Chemicals**”; stock code: 01619) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Tianhe Chemicals** on PhillipMart were HK\$1.90 and HK\$1.82. The price closed at HK\$1.82 per share, 1.10% higher than its offer price of HK\$1.80. The price opened at HK\$1.90, with the most actively traded price of HK\$1.85 per share, and a turnover of 250,000 shares. The total trading volume reached 514,000 shares with total turnover of HK\$948,480.00. The final price of **Tianhe Chemicals**, to debut trading tomorrow has been fixed at HK\$1.80 per share.
