

PhillipMart Announces Pre-IPO Share Price of Earthasia International Holdings Limited (Stock code: 06128)

(Hong Kong – 24 June 2014) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Earthasia International Holdings Limited ("Earthasia**"; stock code: 06128) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Earthasia** on PhillipMart were HK\$1.38 and HK\$1.23. The price closed at HK\$1.26 per share, 5% higher than its offer price of HK\$1.2. The price opened at HK\$1.32, with the most actively traded price of HK\$1.25 per share, and a turnover of 1,438,000shares. The total trading volume reached 3,694,000shares with total turnover of HK\$4,695,760.00.00. The final price of **Earthasia**, to debut trading tomorrow has been fixed at HK\$1.2 per share.
