# PhillipMart Announces Pre-IPO Share Price of

## Chanjet Information Technology Company Limited (Stock code: 01588)

(Hong Kong – 25 June 2014) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Chanjet Information Technology Company Limited ("Chanjet**"; stock code: 01588) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Chanjet** on PhillipMart were HK\$17.10 and HK\$16.56. The price closed at HK\$16.70 per share, 1.95% higher than its offer price of HK\$16.38. The price opened at HK\$16.68, with the most actively traded price of HK\$17.04 per share, and a turnover of 180,400shares. The total trading volume reached 1,867,800shares with total turnover of HK\$31,432,932.00. The final price of **Chanjet**, to debut trading tomorrow has been fixed at HK\$16.38per share.
