## PhillipMart Announces Pre-IPO Share Price of Cosmo Lady (China) Holdings Company Limited (Stock code: 02298)

(Hong Kong – 25 June 2014) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Cosmo Lady (China) Holdings Company Limited ("Cosmo Lady**"; stock code: 02298) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Cosmo Lady** on PhillipMart were HK\$3.60 and HK\$3.45. The price closed at HK\$3.60 per share, it same as offer price of HK\$3.60. The price opened at HK\$3.60, with the most actively traded price of HK\$3.50 per share, and a turnover of 774,000shares. The total trading volume reached 2,615,000shares with total turnover of HK\$9,217,040.00. The final price of **Cosmo Lady**, to debut trading tomorrow has been fixed at HK\$3.60 per share.
