

**PhillipMart Announces Pre-IPO Share Price of  
 Colour Life Services Group Co., Limited (Stock code: 01778)**

(Hong Kong – 27 June 2014) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Colour Life Services Group Co., Limited** (“Colour Life”; stock code: 01778) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Colour Life** on PhillipMart were HK\$4.18 and HK\$3.78. The price closed at HK\$4.17 per share, 10.32% higher than its offer price of HK\$3.78. The price opened at HK\$3.80, with the most actively traded price of HK\$3.80 per share, and a turnover of 306,000shares. The total trading volume reached 2,868,000shares with total turnover of HK\$11,284,420.00. The final price of **Colour Life**, to debut trading next Monday has been fixed at HK\$3.78 per share.
