

**PhillipMart Announces Pre-IPO Share Price of  
 Ourgame International Holdings Limited (Stock code: 06899)**

(Hong Kong – 27 June 2014) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Ourgame International Holdings Limited** (“**Ourgame**”; stock code: 06899) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Ourgame** on PhillipMart were HK\$3.90 and HK\$3.50. The price closed at HK\$3.86 per share, 9.18% lower than its offer price of HK\$4.25. The price opened at HK\$3.80, with the most actively traded price of HK\$3.50 per share, and a turnover of 134,000 shares. The total trading volume reached 652,000 shares with total turnover of HK\$2,396,370.00. The final price of **Ourgame**, to debut trading next Monday has been fixed at HK\$4.25 per share.
